7	PASSPORTS: are required for Portugal. No passport, or an invalid one, means no pilgrimage! Most non-EU Passport holders require a visa. Passports need to be valid until at least 3 months after return (6 months for non-EU residents).		
8	BAGGAGE: Check details of baggage allowance with the airline, when booking the ticket.
